In a number of instances, students have interest or skill in sports not included in the Varsity Intercollegiate Athletic Program at Michigan State University. When possible, this interest may be aided by the utilization of fields, rooms, or areas. It is sometimes possible to provide limited funds, equipment or other facilities in conjunction with efforts and funds by the student groups themselves.

To aid those students with initiative, interest, or skill in the various sports, the Intramural Program attempts to provide the help noted above under the heading of a Sport Club Program.

As students are independent in their leisure time and travels, they may with no University sanction, contact other schools and groups of students and arrange contests both here and away. These contests and travel arrangements by private car or other means are no responsibility of the University, as the students are not representing the University in their activities.

Any injuries resulting from the sport activity or travel in connection with the sport are the responsibility of the student involved. Some coverage is provided by individual student insurance. The same care Olin Memorial clinic offers any injured student is available to students involved in Sport Clubs activities.

Intramural Sports Club participation is completely voluntary. As such, each student assumes responsibility for injuries and subsequent results of injuries that may occur to any citizen engaging in recreation activity. The University shall not be responsible for treatment of defects or injuries that occur during this participation or that becomes apparent after the individual is no longer enrolled at Michigan State University.

TO REDUCE THE CHANCE FOR MISUNDERSTANDING CONCERNING UNIVERSITY RESPONSIBILITY, EACH MEMBER OF THE VARIOUS SPORTS CLUBS SHOULD CERTIFY THAT HE OR SHE IS FAMILIAR WITH THIS STATEMENT CONCERNING UNIVERSITY AND STUDENT RESPONSIBILITY.
